Re: Visit to Iran

Dear Honorable Ambassador,

I am writing to you with regard to the study trip of the Fédération des Jeunes Dirigeants d'Entreprise de Luxembourg (FJD) (Luxembourg Federation of Young Business Leaders) to Iran.

FJD is a not for profit organization in the legal form of a Luxembourg a.s.b.l., whose purpose is to contribute by any means to facilitating and strengthening the effective conduct of business leadership in the economic and social fields.

Since 31 March 1977, the federation has grown from a mere idea to an organization 500 members strong, all joined together with a common goal: a collective interest in developing our economy. Following our commitment to economic life and livelihood, the federation has proved to play an essential role, similar to the roles played by Luxembourg's other economic and political powers. Our activities include working groups, conferences, company visits and yearly study trips.

Following the successful mission to Iran of the Chamber of Commerce of the Grand Duchy of Luxembourg in collaboration with the Ministry of the Economy in October 2016 and the announcement of the honorable Deputy Prime Minister and Minister of Economy, Mr. Etienne Schneider of a visit to Iran of FJD in 2017 to celebrate the 40th birthday, the Federation has arranged for its members to visit Tehran and Isfahan from 29 April 2017 to 3 May 2017 aiming at experiencing Iranian economy and culture.

As a private organization, FJD has not sought the assistance of any government or official in the organization of this trip. Nevertheless, upon request of IRALUX (Iran and Luxembourg Chamber of Commerce), Iran Chamber of Commerce and Industry has agreed to arrange for a meeting on 29th of April to provide a presentation of Iran's economy and culture at their premises in Tehran.


